Minutes of the Carlton Colville Town Council Meeting held on **Wednesday 6 August 2014** at the Methodist Church Hall, Shaw Avenue, Carlton Colville. The Meeting began at 7.00 pm

1a) Welcome by Chairman

The Clerk welcomed Town Councillors and County Cllr Peter Byatt, and Sandra Ward from the Transport Museum, and Members of the Public.

1b) To note Town Council Members present and to receive any apologies for absence and duly note them

Town Council Members present were: Chairman Julie Hall, Vice-Chairman Jill Tyler, Alistair Mackie, Derek Fletcher, Christine Fair, David Kindred, Bill Mountford, Tony Tibbitt and Jack Green.

Apologies were received noted and accepted from the Cllr Wendy Miles.

County Cllr Sonia Barker attends alternate Meetings with County Cllr Peter Byatt.

District Cllr Paul Light sent apologies.

Approval of Minutes as a true record of the Meeting held on 2 July 2014 was proposed and seconded by Cllrs Christine Fair and David Kindred and agreed by all.

The Meeting was adjourned at 7.05 pm

The purpose of the meeting is for Councillors to discuss Town Council business and whilst attendance of residents is welcomed, they are not allowed to join in the discussions of the Councillors.

During each meeting the council will adjourn for a period of up to 15 Minutes to allow for public questions. During this time, residents can put questions to the Chairman regarding local concerns. Where possible, the Chairman will respond but matters may have to be deferred and placed on a later month's agenda for discussion.

ii) Waveney District Councillors

District Cllr Paul Light's report had been circulated, see attachment, and the clerk gave a brief synopsis. There were no reports from District Cllrs Kathleen Grant or Jose Bamonde.

iii) Suffolk County Councillors

County Cllr Peter Byatt answered questions on Suffolk County Council matters including the old Carlton Colville Primary School premises and the traffic at the new Carlton Colville Primary School premises.

Residents raised questions about the future use of the redundant Carlton Colville Primary School buildings, particularly with regard to security if the building was left empty for any

length of time. There were still no concrete answers received from Suffolk County Council to date since Cllr Julie Hall had received information that SCC would not need the school for its educational purposes but that the matter was now with its commercial department.

iv) East Anglia Transport Museum

Sandra Ward reported on the success of the event "Hop on a Bus" day and that party bookings are increasing and that an accreditation has been received from the Association of Suffolk Museums for the care of collections of archives.

Traffic Marshalls are on duty at events.

Cllr Sonia Barker advised that some County Council locality budget could be applied for.

Report to Carlton Colville Town Council, June 2014 - WDCllr P.-

Light

Waveney District Council

At a recent WDC meeting the possibility of facilities for sports teams on Oakes farm was mentioned.

I took the opportunity to say how this might be a good opportunity to consider the expansion of the Transport Museum which is a valuable asset to Waveney and our community. Cllr Grant supported this, as did the chairman, and the other members of the committee were in full agreement.

We also received a presentation looking at the future of Lowestoft that included the work that is ongoing regarding a third river crossing, flood barriers, employment and housing.

This is something the WDC has had a team working on for about 10 years and has always been supported by Cllrs from all parties.

The present bridge was originally purchase second hand and was designed for two lanes of traffic so the need for a replacement has long been high on everyone's agenda.

The many millions of pounds needed have always meant it will need financial support from central government which is why WDC has Officers working hard to help make as strong a case as possible.

Nothing is being done in isolation!

Efforts to bring industry and employment to Lowestoft is also being worked on and links to Gt. Yarmouth could also benefit Waveney residents.

The Enterprise Zone and Assisted Status all should contribute to creating more opportunities.

Some of the offshore jobs can pay £60,000pa!

If all the efforts are successful there could be several thousand new jobs created.

Access to and from Lowestoft is also a challenge, as is the need for a suitably qualified work force.

Sizewell could create more opportunities.

It is appreciated that there is also a problem with traffic congestion at Oulton Broad with the lock bridge and the railway crossing (+ the additional trains). One possibility being advocated is an additional platform to the west of the OB Sth so the trains, from either direction, could stop before the crossing and the barrier is only lowered when they are ready to depart.

We have also carried out a review of a draft Annual Governance Statement which was well discussed and met with cross party support.

Also considered this month have been reports on : the Code of Corporate Governance, Annual Internal Audit Report, Corporate Counter Fraud Annual Report, and Standards Review.

The WDC Constitution is also being reviewed.

I also questioned what the plans were for the present Town Hall.

Everyone present will have read how comments and suggestions are being sought to help determine the most suitable use of this old building.

We were told that there would be a period when some of the offices would still be functioning as part of the phased move to the new building.

I attended the Play Partnership meeting when Carlton Colville was to be an agenda item. Unfortunately, I was the only person there from CC and was not aware of exactly what was to be discussed so could not contribute.

I did question the name of the recreation area of Avelin Way and was told it is referred to simply as "the Avelin Way Green".

Carlton Colville Matters :

I have been contacted re the number of cars being sold in laybys, areas of dog fouling and overgrown footpaths in different parts of the town.

I've now taken to carrying a pair of secateurs when out in the town!

Problems with the addition of an external staircase overlooking a neighbour's ensuit (this was brought to my attention just before the last TC meeting) : -

The application had originally been approved by WDC and CCTC.

I have been in touch with WDC Planning Dept a number of times and visited the home owner who lives on Killock. There does not look to be a simple solution although a well established tree strategically placed might be of help!

On advice, Mr Reen has since received paper work to enable a formal complaint to be made against the decision.

My last conversation with him was that he intended to complete and submit the complaint.

At the last meeting I was told of a problem with refuse lorries using the un-adopted road between Beech & Poplar roads.

I tried several times to speak to Mr Mortimer and emailed the resident's concerns.

I also contacted SCC Highways to try and find out the ownership of this road. I sent a followup email a week later and then visited Waveney Norse offices to learn that Mr Mortimer was actually on annual holiday.

I drew attention to the concerns of residents who had been told they would have to move their bins, particularly as some were not so mobile.

I was assured they would not be expected to move their bins to the bottom of the road.

I have since had a conversation with Mr Mortimer and the new changes to collections had resulted in a change of crews on that route.

I was assured that they would be made aware of the damage lorries were causing to the road surface.

It could mean that they would need to reverse into this road to allow them to continue the round.

General

I attended the launch of the Bloodmoor exhibition and was very impressed by the amount of work that has been done and the history of Carlton Colville. If I understood correctly, it seems we had 'tourists' visiting from central Europe 700,000 years ago

I was recently contacted about the height of the 'weeds' along the banking of the field that is opposite the church because it was reducing visibility for drivers – reducing the time they have to see oncoming traffic.

I contacted SCC and the hedge was trimmed (as part of the cutting programme) but the centre growth remains. I understand this belongs to the farmer who I have not contacted before.

Would it be possible for the TC to ask if it was possible to trim the top?

Has it been possible to talk to the land owner re the escaping horses? I would like to keep the golf club informed of any progress made.

When I checked the notice board there was still no mention of the monthly surgery I have arranged since 2008 - even the TC's page of Cllrs had information about WDCllrs & SCCllrs is folded from view.

If the original posters have been mislaid there is one on the wall of the meeting room that could be copied and displayed.

During my recent illness I did continue to send notices to the Journal and check the availability of Cllrs Grant and Byatt.

July 2014 CC TC Meeting report - additional notes from WDCllr

Since writing my report on June 25th I have attended other meetings.

There have been a public meeting on Priority Setting and a Partnership Meeting.

The 'old style' afternoon Community Priority Setting meetings have ceased as they were not well attended by members of the public, being held during the day.

This last meeting was held at the VI Form College on an evening (although there were about 40 attending the majority were Cllrs and WDC staff)

The meeting largely revolved around presentations on the Lowestoft Rising Scheme and Q's & A's.

Lowestoft Rising: The following are some of the points made by the speakers!

Basically, this brings together the 4 main Public Sector organisations + Voluntary Sector + PCC's office.

The intention is to bring a new 'effective' initiative by bringing everything together.

The aim is to 'improve the quality of the lives of everyone who works, lives, visit or invest in Lowestoft'. It is important that people fulfil their full potential.

There is an emphasis on developing skills and educational achievement and decreasing the abuse of drugs, alcohol, and improving the Mental Health Service.

It is important that we all recognise the positive achievements of Lowestoft and promote a pride in Lowestoft.

With everyone working together Lowestoft will have a united voice and be more effective.

The Journal now promotes positive stories.

Recently a £100,000k grant was obtained to help with a rehab project.

It was implied that the closing of wards at Carlton Court may not be permanent following the result of the public consultation. Allowing that the staff, on these two wards, were made redundant (before the consultation) and there are difficulties finding adequate UK staff to fill vacancies would seem to pose questions.

I believe hundreds of thousands of pounds is spent on engaging locums when possibly permanent staff could save a lot of expenditure.

We were told young Drs do not want to become partners in local practices (although Rosedale continues to expand).

By 2020 over half the population of Lowestoft is expected to be over 50 and this will obviously affect the medical needs of the area.

Lowestoft hospital was no longer of a build quality to provide a quality health service and the Kirkly Mill site was taking on much of the treatments originally located there. (There are two Dr's Practices there but an acute shortage of Dr's.)

The north wing of Lowestoft has been refurbished and due to reopen in September.

An innovation is that 'night sitters' are being engaged to look after people in their own homes so as to free up beds at the JPH.

There were Query / Complaint forms available for people to submit for a reply [I have left two with the Town Clerk if anyone would like to take advantage of this!]

Visited several homes on Beech / Poplar Rds to see if the lorry problem has been sorted.

Most were out but I said collections are now 6-30 + he hadn't seen the lorry, another had not seen anything but did say the lorries drove too fast when they cut through.

The tree, in front of the Beauty Salon, is now very full & blocks visibility for anyone leaving Beech Rd. Could this be trimmed - SCC or Shop??

Having received no reply from Carlton Court re a Day Care Centre I went back.

Found out Age UK now has a Day Care Centre there Tues, Wed, & Thurs for 14 people (11 full)

I collected an information sheet. Could TC put this on their site.

1. SUFFOLK COUNTY COUNCIL MATTERS:

There was no full council meeting during the month of June, 2014.

☒ SCC Cabinet Meeting was held on the 10th June, 2014

During a very full Agenda the following issues were questioned by Cllr Barker – Bury St. Edmunds SOR to date, Home to School Travel Policies 2015/16 and Discretionary Charges from 2014/15, Raising the Bar, Education Other than at School Policy (EOTAS). Other issues covered were: Expansion of school places at two schools, closure of a school, consultation on Progress Power's Gas-fired power Station – comments of SCC, Annual report on children's Social Care and Safeguarding Services, Annual report on Corporate Parenting Board and the Future of the Archaeology Contracting Team.

☒ SCC Education & Children & Young Peoples' Scrutiny Committee was held on the 11th June, 2014

The key issue on the agenda was an investigation of the Careers and guidance provision available to pupils and young people in Suffolk. Evidence was given to the Committee of the current availability of Careers Advice and Guidance by various teachers, school leaders, sixth form leaders and representatives who provide careers education and guidance throughout Suffolk. Cllr Barker was re elected as Vice Chair of the Committee.

☒ SACRE (Standing Advisory Council on Religious Education) was held on 13th June, 2014.

Cllr Barker attended the SACRE meeting and heard that various schools were concerned with the reduction in the teaching time given over to RE which was mostly due to the emphasis being placed on the Baccalaureate Qualification as a requirement in schools at High school level (KS4). In addition the qualification was used as a measure of a school's attainment in league tables.

Policy Development Panel: Education Skills and Young People held on the 23.6.14:- focus on Autism

Cllr Barker attended the above mentioned meeting which was the second PDP meeting to focus on gaining background knowledge and information on the services and support for young people in Suffolk who have Autism.

1. **UPDATE ON CURRENT CARLTON COLVILLE TOWN COUNCIL RELATED MATTERS**

Opening of the `Past Underfoot` archaeology exhibition at Lowestoft Museum

Cllr Barker was invited to the opening of the Archaeological Exhibition called `Past Underfoot` at the Lowestoft Museum on the 14th June, 2014. The Anglo-Saxon artefacts, all found on what is now the Bloodmoor housing estate were discovered during archaeological digs carried out during 2000. Archaeologists working on the site at Carlton Colville found more than 40 buildings and a small cemetery of 26 graves from the sixth to eighth centuries. They also discovered evidence of the earliest Christian converts in the country. The exhibition has been made possible by a £17,000 grant, which was secured from the Heritage Lottery fund last September.

Carlton Colville CP School

Carlton Colville CP School Governors Meeting was held on the 5.6.14 Cllr Barker also attended a school Governors Premises Meeting at the school on the 16.5.14

Feasibility study re the Congestion Solutions outside Carlton Colville CP School

Cllr Barker has chased up via Cllr Graham Newman (SCC Portfolio holder for Roads and Transport) and the new `Our Place` SCC Locality Officer Sue Ranut the whereabouts of the three options feasibility studies that were agreed to be taken forward for costings by all present at the meeting on the 1.4.14. The feasibility study is currently being costed by Keir MG.

Beccles `Free` school – confirmation and next steps

Cllr Barker has chased up the issue raised at the last CCTC meeting in May that there was a need for clarification from the SCC officer regarding the timing of the move from Carlton Colville of the Beccles `Free` school. Cllr Barker is also waiting to hear back from SCC regarding the plans for the Beccles `Free` school site.
